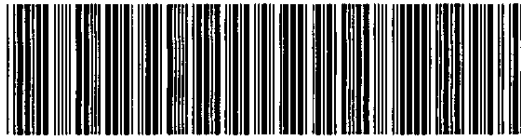

ARTICLES OF INCORPORATION - Amendments  
ESTERO ART LEAGUE, INC.

We, the undersigned, do hereby associate ourselves together for the purpose of amending the Founding Articles of the Estero Art League filed on March 26, 1999 Florida Document number N99000001926 under the provisions of Chapter 617 Florida Statutes 617.0501 and do hereby adopt and declare the following:

ARTICLE III to read

The organization is a non-profit organization to promote education and common interest in art under section 501(c)3. Any monies or assets collected shall be used to further the aims and objectives of this body in accordance with 501(c)3 of the Internal Revenue Code or corresponding section of future federal tax codes.

ARTICLE IV to read

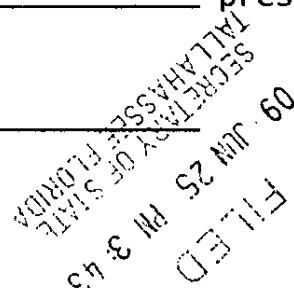
Membership will be open to any adult in Lee County that has a sincere interest in Art, furthering civic and cultural growth of the art community and projecting the aims and objectives of this organization. Membership will not discriminate against applicants on the basis of race, color or national/ethnic origin.

ARTICLE V to read

The corporation shall have perpetual existence unless sooner dissolved according to law. Should there be a dissolution of this corporation, all assets shall be distributed by a Court of Competent Jurisdiction of Lee County, Florida in which the Estero Art League is located for the same purposes or to such 501(c)3 organizations as said court shall determined are organized and operated exclusively for such purposes.

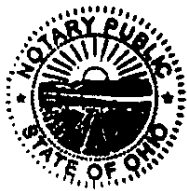
